3	Experience of advancing pupils' progress in a range of classroom settings, including working with individuals, small groups and whole classes, using indoor and outdoor environments
4	Experience of planning, observing and assessing children's learning.
5	Training and experience in learning and behaviour strategies linked to managing young children, including developing children's voice and following their lead.
6	NVQ 3 for Teaching Assistants/Childcare, equivalent qualifications or above.

7	Able to support children who have special educational needs and take a lead role in co-ordinating reviews of pupil's progress including liaising with other agencies as appropriate and recording information effectively.			
8	Excellent written and oral communication skills.			
9	Excellent ICT skills and the proven ability to use them effectively to support learning.			
10	Able to motivate a team and work constructively as part of a team.			
11	Able to relate well to children and adults and in particular able to establish positive relationships with children and parents.			
12	Able to respond positively and effectively to unexpected problems and situations, taking a responsive approach to children's needs to help address barriers to learning and well-being.			
13	Committed to achieving further professional development.
